Jennifer Gardner is a leader in civic design, public policy, and urban planning with over 15 years of experience delivering transformative results across government, nonprofit, and private-sector environments. She specializes in building and scaling programs from the ground up, working at the intersection of design, data, technology, and public systems with experience at the local, state, and federal levels. Known for translating ambitious policy ideas into action, Jennifer applies a human-centered approach—whether managing digital products or designing large-scale infrastructure programs—partnering closely with stakeholders and communities to deliver outcomes that are meaningful and measurable.

Jennifer advances more effective government by designing for equity. In New York City, she architected the Community Parks Initiative, closing a \$1B funding gap in underserved areas by catalyzing the transformation of 160+ parks by 2032 while embedding new approaches to capital planning and public engagement that continue to shape NYC Parks' work. As a strategist with The Lab at OPM and later a White House Presidential Innovation Fellow, she brought innovation practices to national programs, developing digital tools, using research to inform policy change, and advising senior federal leaders on how to improve service delivery for the public. Her work is driven by a belief that service design can simultaneously improve resident experience and strengthen the government's ability to serve.
